# SPECIAL BUSINESS (Chief Hoyle)

Chief Hoyle invited Jessica Spencer, project director of the Manatee County Substance Abuse Prevention Coalition to come and speak in regard to the "Your Life Matters" cards inspired by Firefighter Michael Dunn. She presented the newly printed cards. Chief Hoyle presented a Notable Outstanding Work Award to Firefighter Dunn. The award read as follows: *In Recognition of the Development of "Your Life Matters," Providing Another Level of Caring Service to Citizens in Our Community Experiencing the Personal Crisis of Addictions.* 

Chief Hoyle announced the retirements of Firefighter Zeke Eckersen on May 15, 2015 and Captain Ed Shumaker on June 31, 2015. He stated we would be conducting flag ceremonies for each.

Chief Hoyle announced the promotion of Firefighter Brant Gomez to Second Class Firefighter.

## **OLD BUSINESS**

Chief Hoyle presented Cedar Hammock Fire Control District draft legislation (HB 1203) with edit marks by Maggie Mooney Portale, Esq. and reviewed the 2015 Economic Impact Statement Form for HB 1203.

#### **NEW BUSINESS**

Chairman Litschauer asked if there was any new business to add to the agenda.

Chief Hoyle requested an item be added to the agenda: **Parrish Fire District Draft Bill of Sale**. Chief Hoyle stated that Parrish Fire District wished to purchase a 2004 Ford Expedition surplus vehicle at \$5,000. A copy of the draft bill of sale is included in these minutes

ACTION: Commissioner Flynn moved to proceed with the sale of the 2004 Ford

Expedition surplus vehicle for \$5,000 to Parrish Fire District and gave permission to Chief Hoyle to execute the bill of sale and any documents related

to the transfer of title.

Commissioner Bennett seconded the motion.

The motion passed unanimously.

Division Chief DeChelbor announced he would be advertising the sale of the remaining two surplus vehicles to the public.

Division Chief DeChelbor reviewed the 2014 ISO Survey. He stated the District remained at a high 3 rating.

Chief Hoyle requested the Property Acquisition agenda item be removed because the property had sold. Commissioner Holderness requested to revisit this item.

Commissioner Holderness researched the recent purchase and availability of the property located at 2615 52<sup>nd</sup> Avenue Terrace West. He was able to ascertain the owner of the property might be willing to resell the property for approximately \$87,000. Discussion ensued.

ACTION: Commissioner Flynn moved to tender an offer to purchase the property located

at 2615 52<sup>nd</sup> Avenue Terrace West for the sum of \$87,000.

Vice Chairman Brunner seconded the motion.

The motion passed unanimously.

Commissioner Holderness clarified he is not benefitting from the purchasing/acquisition of the property. This transaction is being done as an arm's length transaction.

Chief Hoyle reviewed the budget amendments as presented in the exhibit. He requested board action for Resolution 2015-01 Budget Revision – A resolution of the Cedar Hammock Fire Control District of Manatee County, Florida, amending and adopting certain budget revisions for the fiscal year 2014-2015, providing for an effective date.

Commissioner Bennett seconded the motion.

# **CHIEF'S REPORT**
