2016-2017 FINAL BUDGET

**A RESOLUTION OF THE CEDAR HAMMOCK FIRE CONTROL DISTRICT  
OF MANATEE COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET  
FOR THE FISCAL YEAR 2016-2017, PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Cedar Hammock Fire Control District (“District”) is an independent special purpose taxing district authorized under the provision of Chapter 189 and 191, Florida Statutes, and Chapter 2015-197, Laws of Florida (“Special Act”); and

**WHEREAS**, the Board of Fire Commissioners of the District held properly advertised public hearings on September 7, 2016, and September 22, 2016, for the purposes of adopting a Final Budget for the fiscal year 2016-2017 in accordance with the provisions set forth in the District’s Special Act and applicable general law; and

**WHEREAS**, the Board of Fire Commissioners of the District set forth the appropriations and revenue estimate for the Final Budget for Fiscal Year 2015-2016 in the amount of \$9,870,632.

**WHEREAS**, through the adoption of this Final Budget, the Board of Fire Commissioners of the District has committed funds in the amount of \$1,228,804. to the following: Accrued Leave/Sick Time/Vacation; Communication Equipment/Station Alerting; Major Vehicle Repairs; Tax Refunds, Station Renovations; Vehicular Replacement; and Fire Engine Replacement.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Fire Commissioners of Cedar Hammock Fire Control District, Manatee County, Florida, that:


1. The above recitals are true and correct and are incorporated fully herein by reference.
2. The Fiscal Year 2016-2017 Final Budget, attached hereto and incorporated herein as Exhibit 1, is hereby adopted.
3. This resolution shall take effect immediately upon its adoption.






